



The PC Network: is a network of small businesses, nonprofits and groups of individuals who are contracted to use each other and a specific set of corporate service providers by using one financial platform. Corporations pay for the guaranteed clients or customers and the card holders receive services or funding for using the card and platforms exclusively.

To register with the Carolina Business to Business Network.

The Carolina Business to Business Network along with several agencies has developed a solution that will provide long-term funding for small businesses and nonprofit organizations through a group purchasing network. The network is accepting applications from 500 to 3500 small business owners and community leaders who will contract to use the PC Commercial purchasing card for their daily operations, bills, payroll and expenses every month in re-turn for \$1,500 to \$10,000 per month in payments.

Your \$300 Membership, your commitment to purchasing with the group is what pays for these services and your \$1,500 to \$10,000 monthly payout.

Group purchasing networks are not new, the uniqueness of the PC Network is that the network redistributes funds to the members in cash instead of CEO's and Shareholders. The PC Network will evenly distribute the funding to the communities and the organizations that are using the services of the Media Centers and the PC Debit Card.

More specifically, we are trying to better understand how group purchasing, corporate accountability and purchasing from each other will effectively fund and strengthen local small businesses and nonprofit organizations resulting in safe and prosperous neighborhoods.

Up to ten thousand dollars per month is available for organizations who will commit to spending these funds on their daily operations and bills using the PC Debit card, the website and the financial platforms.

All members are contracted to use the PC Debit Card partners for startup, expansions and operations.

BRIEF SUMMARY

The PC Debit Card started-out as a multimedia membership service twenty-five years ago and has been tested in cities nationwide and with many industries and demographics.

The PC Debit Card is a Group Purchasing Network that charges corporations a fee for exclusive business contracts with the members. The amount that is collected through the debit card system is paid-out every month to the debit card members. Members are contracted to use the paying-corporations (exclusively).

The system is setup and operates serving groups of 500 to 3,500 small businesses and organizations.

The first phase of the PC Debit Card is being launched through a unique funding program, The Two Million Dollar "Funding-Solutions" Campaign. This campaign will distribute an average of four thousand dollars per month to each member of the group of 500 organizations, totaling two million dollars per month.

The campaign will demonstrate the PC Debit Card's ability to electronically collect fees from the corporations and distribute the fees to the participating members who are primarily nonprofit community organizations, youth programs and projects.

HOW THE SYSTEM WORKS

500 commercial card members and One million individual card members per region or per one million residents, serviced by demographic and industry will be spending together using one website and one financial platform to purchase from the contracted corporations. The members will also sell and purchase their services and products from their individual PC Web Accounts on the network.

Corporations compete for contracts and pay a minimum of 7% on the "guaranteed-minimum-contracts." The Revenue generated from the corporations are electronically distributed to all active network members every month (commercial and Individual members).

Commercial Card Members:

500 organizations spending \$10,000 month = \$60 million dollars per year. Six Regions spending together = \$60 million per month. 7% to 10% Commission on \$60 million dollars = \$5 million dollars (distributed to card members).

Individual PC Card Members

One million users spending \$1,000 per month = one billion dollars. 8% to 12% commission on One Billion is \$100 million dollars (distributed to members).

All funds are revolved out of the account every 30-day cycle.



The \$2 Million Funding-Solutions

Campaign serves as the first phase of the PC Debit Card (the testing phase).

500 businesses and nonprofits spending an average of seven million dollars together allows each organization to receive \$1,500 to \$4,000 of the two million dollars each month.

HOW ARE THE TWO MILLION DOLLARS GENERATED?

200 Corporations Paying \$10,000 plus 7% for the guaranteed contracts to serve the 3,500 debit card members.

The members are contracted to use the PC
Debit Card for operations and business
expenses.







The PC Debit Card started-out as a multimedia membership service twenty-five years ago and has been tested in cities nationwide and with many industries and demographics.

The PC Debit Card is a Group Purchasing Network that charges corporations a fee for exclusive business contracts with the members. The amount that is collected through the debit card system is paid-out every month to the debit card members. Members are contracted to use the paying-corporations (exclusively).

The system is setup and operates serving groups of 500 to 3,500 small businesses and organizations.

The first phase of the PC Debit Card is being launched through a unique funding program named The Two Million Dollar "Funding-Solutions" Campaign. This campaign will distribute an average of four thousand dollars per month to each member of the group of 500 organizations, totaling two million dollars per month.

The campaign will demonstrate the PC Debit Card's ability to electronically collect fees from the corporations and distribute the fees to the participating members who are primarily nonprofit community organizations, youth programs and projects.
